

**ORDINANCE NO. 2020- 3**

**AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF LIVERMORE, IOWA, BY AMENDING PORTIONS OF TITLE VII, CHAPTER 1-5, AND ORDINANCE 2018-6 “ELECTRIC UTILITIES, RATES”.**

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LIVERMORE, IOWA:

Section 1. That the Code of Ordinances of the City of Livermore, Iowa, be amended by repealing 7-1-5 “ELECTRIC RATES” and Ordinance 2018-6 and the following adopted in lieu thereof:

7-1-5 ELECTRIC RATES. The rates for electric services shall be as follows:

RESIDENTIAL

Effective December 1, 2020:

Electric Base Fee: \$21.75 per month

PLUS

Electric Rate: 0.1113/kWh

Effective December 1, 2021:

Electric Base Fee: \$22.50 per month

PLUS

Electric Rate: 0.1127/kWh

Electric cost adjustment is applicable

COMMERCIAL SINGLE PHASE

Effective December 1, 2018:

Electric Base Fee: \$38.50 per month

PLUS

Electric Rate: 0.1146/kWh

Electric cost adjustment is applicable

COMMERCIAL SINGLE PHASE – HIGH LOAD FACTOR

(ADVERAGE USES OVER 4000 kWh/monthly)

Effective December 1, 2018:

Electric Base Fee: \$38.50 per month

PLUS

Electric Rate: 0.1100/kWh

Electric cost adjustment is applicable

COMMERCIAL THREE PHASE

Effective December 1, 2020:  
Electric Base Fee: \$59.00 per month  
PLUS  
Electric Rate: 0.0431/kWh  
PLUS  
Demand Rate: 16.34/Kw  
PLUS  
50% Demand Ratchet

Effective December 1, 2021:  
Electric Base Fee: \$60.00 per month  
PLUS  
Electric Rate: 0.0431/kWh  
PLUS  
Demand Rate: 16.9/kW  
PLUS  
50% Demand Ratchet

Electric cost adjustment is applicable

Energy Cost Adjustment Clause

Monthly rates adjustment (charge/credit per kilowatt hour) shall be added to the customer's monthly rate to account for the difference in the City's actual purchased power cost and the amount billing customers for purchased power through based rates.

Section 3. Severability Clause. If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

Section 4. This ordinance shall take effect December, 2020 upon publication or posting.
